Complete the reservation form for Non Girl Scout Use.

Send reservation form with payment check, damage deposit check and certificate of insurance. Insurance should cover bodily injury and property damage in an amount not less than \$1,000,000. If your insurance policy limits are less than the required \$1,000,000.00, please submit a letter of waiver, along with a copy of your policy, indicating that you accept full responsibility for any costs that exceed your policy limits.

If the organization employs staff to use vehicles on the above described premises, additional coverage is required to include workers' compensation and employers' liability.
